Cirsa announces that, in accordance with the provisions of section 2 of Rule Four of Circular 1/2017, dated April 26, issued by the Spanish National Securities Market Commission regarding liquidity contracts ("Circular 1/2017"), the Company signed a liquidity contract (the "Liquidity Contract") on October 31, 2025, with ALANTRA EQUITIES SOCIEDAD DE VALORES S.A. (the "Financial Intermediary"), whose operations will commence following the Previous Period communicated through Other Relevant Information No. 37499 on November 3, 2025.

For the purposes of section 2(a) of the aforementioned Rule Four, the following is hereby disclosed:

- 1. <u>Security subject to the Liquidity Contract:</u> Shares of Cirsa Enterprises, S.A. (ISIN ES0105884011).
- 2. <u>Markets where transactions will be executed</u>: Transactions will be carried out on the Madrid, Barcelona, Bilbao, and Valencia Stock Exchanges through the Stock Market Interconnection System (Continuous Market).
- 3. Term of the Liquidity Contract: 12 months, renewable for an identical period.
- 4. <u>Number of shares allocated to the securities account associated with the Liquidity Contract:</u> 73,300 shares (SEVENTY-THREE THOUSAND THREE HUNDRED). A summary of the transactions carried out during the Previous Period is included in **Annex 1**.
- 5. Amount allocated to the cash account associated with the Liquidity Contract: €996,880 (NINE HUNDRED NINETY-SIX THOUSAND EIGHT HUNDRED EIGHTY Euros) will be deposited in the cash account associated with the Liquidity Contract.
